**Non-Pyrogenic** - Tested and met the criteria established in the current version of ANSI/AAMI ST 72, "Bacterial Endotoxins - Test methodologies, routine monitoring, and alternatives to batch testing" and USP <85>, "Bacterial Endotoxins Test".  $DNase/RNase\ Free$  - Tested by nuclease assay method and found to be free of detectable DNase/RNase contamination. The assay detection limit is  $10^{-7}$  Kunitz units/uL for DNase and  $10^{-9}$  Kunitz units/uL for RNase.

**Sterility** - Product has been sterilized and dosimetrically released per the requirements of ANSI/AAMI/ISO 11137, "Sterilization of health care products- Radiation". Products meet a minimum Sterility Assurance Level (SAL) of 10<sup>-3</sup>.

**Volumetric Accuracy** - Serological pipets are accurate to +/- 2% at full volume in compliance with ASTM E934, "Standard Specification for Serological Pipet, Disposable Plastic" and ISO 12771, "Plastics laboratory ware - Disposable serological pipettes".
