**Sterility** - Products labeled Sterile Fluid Path have been designed to ensure sterility of the portion of the product intended for contact with fluids.

**Tissue Culture** - Tested for the attribute of cell attachment and growth utilizing an attachment-dependent mammalian cell line. A minimum of three population doublings and a confluent surface is required for acceptance.
